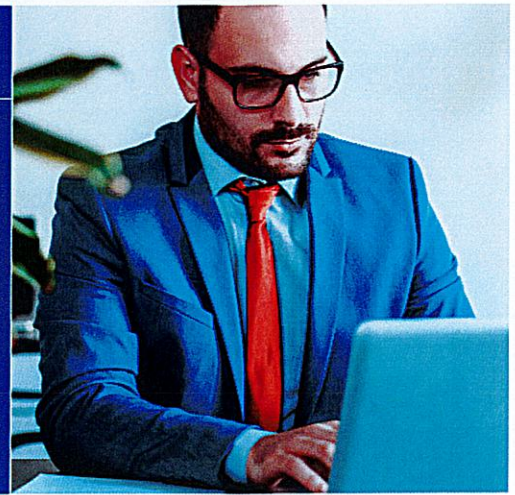

*Participants who are age 50 or older, or who will reach age 50 during the calendar year, are allowed to make additional "catch-up" elective deferrals over and above the current elective deferral limit.
